1. <u>Vote (For or Against) To Increase PTIA Dues</u> – President Miller from \$36 to \$50 beginning July 1, 2023

The voting process was conducted through 1) polling via Zoom (initiated by Cherryl Montgomery); and 2) written ballots were opened (along with text messages) and tallied by Vallory Hills, Secretary. Vallory will keep the written ballots/text messages for one week in the event someone wants to review them.

The majority of votes <u>approved the PTIA Dues Increase from \$36 to \$50</u> beginning July 1, 2023.

In addition, people who have paid dues in advance will not be grandfathered. Separate notices will be sent to all residents who have paid in advance for more than one (1) year.

It was noted by President Miller that future voting (with regards to ballots) will be opened in person and witnessed by at least 3 persons.
