- 1. Call to Order

- 7. Officer Election

President Elbert-McClain stated that she had received a resignation letter from Harry Horton, relinquishing his officer position as Treasurer. Vera Hollins was nominated as Treasurer. There was no opposition. It was moved by Cynthia D. Miller to accept Vera Hollins' nomination as Treasurer. Seconded by Harry Horton. Motion passed.

B. Revise/Update Bylaws (seek advice)

President Elbert-McClain stated that the Bylaws need to be revised/updated in that there are items that do not coincide with the RS 33:9097.29 Statute. 10. New Business

A. Recent Crime in Neighborhood

President Elbert-McClain spoke about the recent crime in the neighborhood (burglary, car theft, attempted car theft). She read the police report from Officer Harrell.

B. Installation of Fencing behind Melban Residents (7ft-8ft)
Cynthia D. Miller suggested the idea of 7ft-8ft fencing along the canal at the dead end of Alba Drive and behind the residents on Melban Street. She will have quotes for the December 2, 2024 meeting.

She did mention that before any work is done the residents on Melban Street (butted against the canal) will have to give their approval.

The subject of LED lighting came up, to which Ms. Miller stated that she spoke to Mayor Waites. The Mayor told her that the LED lights have been paid for but that he was waiting on an installation date.

C. Large Crime Prevention Sign (Recycle or Trash) Crime Prevention has a large sign that is being unused due to its awkwardness. Eddie will get the sign from Joe Jenkins and see if it can be salvaged.

D. Installation of Cameras

a. Front Entrance – Chief Carl Dunn, Baker PD (not in attendance)

Officer Randolph Harrell was in attendance at the meeting and spoke on the following:

- i. Speeding on Alba Drive exceeds 37mph.
- ii. Most tickets written for speeding and/or running the stop signs are guests in the neighborhood.
- iii. The Cameras at the Front Entrance are only LPR (License Plate Readers). They do not capture a person's image. These cameras work with Wi-Fi.

- iv. Baker Police are looking to obtain Flock Cameras through a grant that someone will have to write.
- v. Residents should focus now on installing additional lighting around their homes, especially motion-detector lighting.
- b. Camera at Alief (Dead End)
- c. Cameras at Alba (Dead End)

There was some discussion about the installation of Cameras in items b. and c. above, however, due to time constraints the meeting had to be adjourned.

It was moved by Eddie Young to table Agenda Items until the December 2, 2024 meeting. It was seconded by Cynthia D. Miller. Motion passed.

Parcel Fee.

(c) The fee shall expire ten years from its initial levy but may be renewed as provided in Subparagraph (a) of this Paragraph. If the fee is renewed, the term of the imposition of the fee shall be as provided in the proposition authorizing such renewal, not to exceed ten years.

- (3) (a) At least thirty days prior to any election held to approve imposition of a parcel fee, the board shall mail notification of the upcoming election to each registered voter of the district and to the owner of each parcel fee if the owner is not a registered voter of the district.
