Neighborhood Restrictions

No Speeding

Speed limit for Parkwood Terrace is 25mph. Please be mindful of children and neighbors who walk and ride bicycles. Baker Police Department patrols the neighborhood regularly.

Safety First

Walkers or bicycle riders who are active early mornings or late evenings should wear reflective clothing, have flashers on their bicycles, or wear safety vests.

Parked Cars

Parish Ordinance: Vehicles are prohibited against permanently parking on the street. Visitors may park for several hours.

Drainage on Streets; Obstruction of Gutters, Ditches and Drains

Parish Ordinance: No person shall impede or obstruct the passage or flow of water over or on any street, gutter, ditch or drain, or on any property whether owned by the City of Baker, or the Parish of East Baton Rouge.

EBR Parish Animal Control & Rescue Center

Parish Ordinance: EBRP has a strong "Leash Law" that essentially requires animals be leashed or confined at all times. This protects citizens and their property from dogs that are roaming...

EBR Parish Animal Control

& Rescue Center

Parish Ordinance, Cont'd:

...unsupervised. Owners are held strictly liable for any actions their animals take in EBRP.

City of Baker Ordinance Article II. Domesticated Animals

Sec. 4-55: Owner's Responsibility

(b) Other Provisions

(5) No dog shall cause any excessive noise making or excessive barking. The animal control center will respond to excessive noise making and excessive barking dog complaints.

Sec. 10-31. - Noises interfering with enjoyment of property or public peace and comfort prohibited.

No person shall make or cause to be made any loud and raucous noise in the city which is offensive to persons of ordinary sensibilities, and which renders the enjoyment of life or property uncomfortable or interferes with public peace and comfort.

CONNECTING GU272 TO SU: CREATING A MEMORY PROJECT OF SURVIVING DESCENDANTS CONNECTED TO SOUTHERN UNIVERSITY

History brought Georgetown University 272 (GU272) descendants to Southern University and A&M College. The GU272 was the nearly 300 men, women, and children owned by the Maryland Jesuits and sold to two Louisiana planters, Governor Henry Johnson and Jesse Batey in 1838. The GU272 included 40 different families with long roots on the Jesuits' Maryland plantations, including St. Indigoes, Newtown, St. Thomas Manor, and White Marsh.[1]

The most notorious incident of Georgetown's history with slavery was the sale of the 272 enslaved people, known today as the GU272, by the Jesuits of Maryland in 1838. To keep the university financially viable, two of Georgetown's early presidents sold these men, women, and children for a total of \$115,000—roughly \$3.3 million in today's money.

Among the families were the Hawkinses, Butlers, Hills, Harrises, Mahoneys, Scotts, and Queens, as well as many others. Some of the people enslaved by the Jesuits sued their owners for freedom in the late 18th and early 19th centuries and won; others remained in bondage and were "sold down the river" to Louisiana.[2] They ended up on plantations in Iberville, Ascension, and Terrebonne Parishes, across the river from Baton Rouge about 30 miles from the location that became Southern University and A&M College. Many of their descendants still live there today, in towns such as Maringouin, Rosedale, and Grosse Tete.

The slaves were Catholics, many having been baptized by Father Thomas Mulledy, President of Georgetown from 1829 to 1837, or his successor, Father William McSherry.

The two men determined in 1838 that selling most of the college's slaves was both expedient and necessary. In addition to having concerns about the college's pressing financial needs, the Jesuits may have calculated that the cost of owning slaves was more expensive than paid labor. They were also likely aware that public sentiment in the District of Columbia was beginning to shift against slavery.

The GU272 and their descendants rebuilt their lives in Louisiana. Many of the original GU272 endured slavery in the sugar cane fields and witnessed Emancipation. Many of the descendants still live in southern Maryland and Louisiana today. We now know that the number of individuals sold during this sale was at least 314. Tradition claimed that all perished on the way to Louisiana, but they survived – many of them through the Civil War living long enough to see Emancipation.

"Cade Library is pleased to be a part of this important project which preserves the rich history and culture of descendants of the GU 272," says John B. Cade Library Dean Dawn Kight, Ph.D. "We will continue to expand the collection and make connections with alumni, former employees, and anyone who is a descendant and who has a relationship with Southern University."

Over 8,000 of their descendants are now known and the numbers continue to grow. It is a story of perseverance and survival. (Full citations in the attached.)

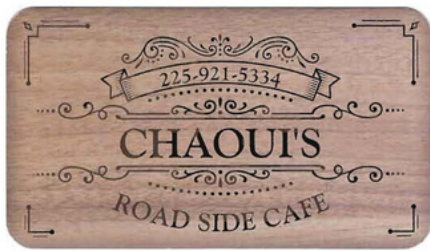
